

# Choice Dollars<sup>®</sup> Details

The Thrivent Choice<sup>®</sup> program lets eligible members recommend where some of Thrivent Financial's charitable outreach funds go by directing Choice Dollars. The 2016 details are outlined below.

#### **Member Eligibility Requirements**

To be eligible to participate in Choice Dollars, you must be a benefit member.<sup>1</sup> Individual eligibility is also based on at least one of the following:

- Holding a qualifying Thrivent Financial volunteer leadership position.
- Having \$750 or more in annual premiums of qualifying insurance products.
- Having \$20,000 or more in contract value of qualifying products.

Member eligibility under current eligibility requirements is determined monthly, and these eligibility requirements are reevaluated on an annual basis.

#### Minimum and Maximum Choice Dollars Designations

• Eligible benefit members will be designated a minimum of \$25 Choice Dollars and a maximum of \$5,000 Choice Dollars per eligibility period (January 1 to December 31).

#### **Choice Dollars Expiration Date**

Choice Dollars designated during the calendar year can be directed until March 31 of the following year. For example, you can direct Choice Dollars designated to you in 2016 until March 31, 2017.
